

## STUDENT URGENT SUPPORT BENEFIT to “Continue studying & research” by the Gov.

### OVERVIEW

For those students who are self-supporting and have been having financial difficulties because of the spread of coronavirus, you can apply for *STUDENT URGENT SUPPORT BENEFIT* in order for you to continue your study and research in this university.

### AMOUNT

Resident tax-exempt household: 200,000JPY/person      Others: 100,000JPY/person

### WHO CAN APPLY

For international students, **MUST** meet the all criteria below. (①-⑤&⑦)

#### I Self-supporting and pay for tuition from your part-time job salary

- ① No remittance from your family in your home country → Remittance less than 1,500,000JPY/year (including tuition)
- ② As a general rule, you are not living with your family → You are making your own living and pay for rent.
- ③ Cost of living and tuition and fees are the main expenses of your part-time job wages
- ④ Because of financial difficulties/decrease in income of your family, either parents of yours, you can't expect an additional support from your family.

#### II Your earnings have dropped drastically because of the spread of coronavirus

- ⑤ You have experienced major decrease (50% drop compared with the last month) in your part-time job wages (including financial aid from employment adjustment subsidy) because of the spread of COVID-19.

#### III You are trying to maintain and continue “your study/research” from the long-term perspective by getting support from any available benefits.

⑥ → Only for Japanese students.

- ⑦ For international students, you must meet all the criteria below and must be having financial difficulties caused by the spread of COVID-19.

(Same as “JASSO Honor’s Scholarship”)

- 1) Your last year’s grade, GPA calculated by JASSO system, must be above 2.3 point.
- 2) Your class attendance is over 80%.
- 3) Remittance is less than 90,000JPY/month (not including entrance fee · tuition and fees).
- 4) Your dependent’s income is less than 5,000,000JPY.
